

**INVITATION TO ARBITRITE®**  
JUSTICE ON DEMAND™

Dear \_\_\_\_\_,

You are invited to participate in an on-line, dispute resolution process that permits parties to resolve their claims and differences by expedited arbitration. Each party has an opportunity to simultaneously submit a (written or video) statement of the case, upload supporting exhibits, and submit a reply. The parties' dispute is decided by an anonymous panel of three (3) neutral attorneys, including a retired judge who acts as umpire. All Panel participants are unbiased, and are picked for their legal expertise in the disputed area.

Once the case is submitted (on a schedule set by the parties); the ARBITRITE® Panel must research, write and render its legal opinion by the Decision Deadline – also set by the parties. The parties must decide in advance whether they want a non-binding advisory opinion – which does not have the force of law. Or, they can elect binding arbitration, in which case the ARBITRITE® Panel will render an Award in Arbitration – which can be enforced as a final judgment by any court of competent jurisdiction. Our Case Coordinator is always available to help with administrative questions. You may, of course, use an attorney, but most parties proceed without legal counsel.

You are encouraged to consult an attorney if you would like a fuller understanding of how ARBITRITE® differs from traditional arbitration or litigation. In short, an agreement between the parties to ARBITRITE® can bring the satisfaction of justice and the peace of finality at a fraction of the cost of litigation.
